Dear Mrs. Gaus

I refer to my various letters and my request for personal contact to you after you initially advised me to consult a lawyer for this purpose.

I told you that I did not find any lawyer for this job and that I would not go on looking for one anymore. You know what we are dealing with and I may expect that everybody involved, including you, refrains from acting as it was a play. It is not. I reported holocaust crimes in immediate context with various genocides and I am about to prevent the Earth from the next/last world war which my evil family seems to forge. You only need to follow news and you know what I am talking about. Syria is only one venue of the growing world conflict and shamefully appears to be fought out as representative war (Stellvertreterkrieg) in avoidance of "a clash of civilizations" (compare the book of the same name of Samuel P. Huntington ((deutscher Titel "Kampf der Kulturen – Die Neugestaltung der Weltpolitik im 21. Jahrhundert") and the book "Die Mächte der Zukunft" von Helmut Schmidt).

For the true translation of the expression "civilization" as Kulturkreis/Hochkultur instead of Zivilisation please refer to the respective remark at the end of Huntington's preface on page 14. As a German I would say it a little bit clearer as follows: Whereas "civilization" in French and English implies civilized populations without significantly increased rates of psychopathology due to heavy holocaust culture and "culture" describes the latter ones the use of German language is not familiar with this differentiation (for obvious reasons if you take into account that Germany is abused as the world's stove of the catholic holocaust). To clarify my similar use of these expressions I talk about civilizations when I mean widely holocaust free countries/populations and about culture-circle(s) otherwise. In fact there is only one culture-circle the western hemisphere that I would call alike.

Whereas Huntington and Schmidt describe the future of world politics as a conflict of the major civilizations respectively culture-circles I, again, would like to name it as it is, i. e., as a conflict between the major world religions. Christianity Islam and the relative religions Buddhism Hinduism and Chinese variations whereby the latter three by far the most peaceful are and the first by far the most aggressive is due to its evil catholic lead. Islam (Near East) is attacked by it why Islam has to defend itself more intensively than those of Far East.

This true war is fought out via representative wars on the back of individual and collective peoples on the peripheries of the involved civilizations/culture-circles instead of their core nations with effect on individuals and collective Earth consciousness. The decisive resolutions and directives, however, are made in and forwarded from ghostly (catholic)/spiritual (others) dimensions.

Likewise the people of Syria as collective Carmen and me and her little family as well as my one as individuals are abused for the purposes of this evil (non)fucking eternal catholic aggression what more precisely would be called **bellum mundum**. As result her brother was murdered and her handicapped daughter taken as hostage in an ugly LIFE despising manner. My wife was murdered my children taken as hostages and my consciousness and mind extremely terrorized and abused as people suppressing vehicle. Moreover, both of us have been infected with HIV (serving as dog line).

I remind you at my letter to Mr. Joschka Fischer of 11 November 2017 published in the context of my literate estate "Kafkas Erbe" on <a href="www.familienzuechtigung.com">www.familienzuechtigung.com</a> which you certainly read. I described the effect on my self-confidence and the lost of my confidence in my own kind of human beings resulting from the sudden opening of my thoughts to everybody around and the fact that this seemed nothing new to everybody else.

Especially the intentional delay of this development of my senses of at least twenty years would have been more than suitable for causing my chronic mental insanity or even suicide. This, even, happened often enough in cases in which this development took place in the natural time-context of puberty only because collective and spiritual consciousness are not only not talked about but kept secret to be used abusively in the western hemisphere. At least two close friends of mine died from this reason. In the letter to Mr. Fischer I explained, furthermore, why the reunion of Carmen and me would save NATURE and have healing effects on psychopathologic western societies who suffer next to and more than from other methods concretely from the catholic attacks on LOVE conducted by their state secretary offices like AA (Auswärtiges Amt) in Germany using inhuman methods as the infamous Julia and Romeo scheme. This was proved by the historic commission appointed by Mr. Fischer whose members risked, one – Prof. Ashby Turner (New Haven) – even lost, their lives. Our reunion needs to happen quickly as long as my mind still is transparent (I assume that the natural development of my senses goes on until this transparence is replaced by the same participation of the collective consciousness as yours for example). In addition, the death of Prof. Turner would not remain senseless if we came back together still being in the centre of collective and spiritual consciousness. I doubt that any pair of the next "victims" will ever be as clear and true as we are, i.e., I doubt that this chance will ever come back. So, we can use this chance for commonhealth (precondition of commonwealth) what means too that there will not be further victims or let it pass and the next victims will be only of catholic use again.

In categories of law my over 42 years grown confidence as by higher law protected fact was abused by everybody close to me inhumanly beginning with my smelling catholic mother and my brother who presented himself as demagogic University professor when I visited one of his beginners criminal law lectures a few weeks ago in which he pretended to regret the death of one of his best students who had disagreed with the injustice happening in summer 2015 (meant was my rebuke from my father's house) and who was in the following killed in a traffic accident caused by too fast drivers who were not even punished appropriately. His students understood him like I understood him since "numerus clauses" provides for full sense developed students of law. After his lecture I tried to talk to him but he refused arrogantly referring to his "order" (?) that I may not contact him. Shortly thereafter I received a letter of the University that I was prohibited to enter it again (another ridiculous "Hausverbot" without reason that the house owner - not even the public and semipublic (discount supermarkets e. g.) one - do not need and therefore is enforced all the time over the current victims as another people frightening and suppressing means).

Next to my family my complete environment was urged to lie at me and hide the truth of my destiny allegedly to be sacrificed to the fight against holocaust but which in the meantime turned out as catholic **bellum mundum** for the whole period since the "illuminating seminar"

in the beginning 90ies (reported by Sabine Bode in "Die vergessene Generation" what I wrote you in my letter of 9 February 2018) until the beginning of my delayed sense development in 2012 and who not even changed back to honesty thereafter.

Whereas these are the backgrounds for my abuse and the abuse of justice including prosecution services like most recently the infamous use of my daughter to accuse me of the wrong allegation of body violation (Körperverletzung) and even to apply for allowance as second accuser (Nebenkläger) which caused the PO (Staatsanwaltschaft) to open research proceedings (Ermittungsverfahren, please see file no. 520 Ds 691/17) and more than ever shaming to use my other not even 14 years old daughter as witness my legal interests which correspond with the whole catalogue of my major personal human rights are ignored completely despite my meanwhile numerous and more than clear and well known true reports. Your PO colleagues who share the collective knowledge of all about it like everybody else might have slept too deeply that Sunday afternoon when the incident with my daughter took place and I reacted more than appropriately to the evilly influenced behavior of my daughter who used violence first grasping my clothes hysterically and forcing me to give her a box on the ear for the very first time in her life.

The local court (Amtsgericht Köln) informed me about the application of my daughter with letter of 15 February 2018 together with a letter referring to another infamous criminal case of the same court of 7 February 2018. I received both letters on 20 February 2018! This time maybe not due to the public post services but intentionally delayed by the court since there were no post stickers ("Irrläufer") on the envelopes. As you know local court and regional court (Amtsund Landgericht) are in the same building and as you might not know the wife of my brother, Mrs. Dr. Simone Kreß, being the vice president of the regional court.

With respect to the case 520 Ds 691/17 the court asked for my point of view with a ten day notice. However, I am not about to reply since I feel (and am) extremely abused by the catholic controlled <u>Federal</u> Republic of Germany and refuse to play along in this non-game of ghostly religious world war.

I ask you once more to treat me and deal with my case on the basis of these true facts. If they are not kept hidden anymore and dealt with as they are you help to prevent the outbreak of the next open world war. If you, instead, are not able or afraid to do so, please let me (hence the cc. recipients too) know at least in order to grant me the very minimum of a human treatment as you probably understand that I am not willing to serve as play ground for the catholic warlock Franziskus but to leave the country shortly in this case. If, on the other hand, you are willing to stop this unbelievable abuse of **NATURE** you have many options to begin with and

inform me accordingly. Please do not think that research tactics could be a convincing reason for not informing me because my mind is transparent and if you inform me you inform the world, including the criminals of your intended steps. In contrary, as long as my mind is transparent and I am going on to report the complaint about my best but (still?) ineffective efforts of reestablishing our human rights to civilized **international authorities** of doubtless integrity (as well as civilized colleagues of the German legal society; cc recipients) you are as save as I am myself.

Besides, there are no mysterious next steps which would help law instead of intrigues means to prevail (for whatever purpose which does (maybe holy in catholic eyes but) not heal (in legal terms) the means). My brother and mother are speculating everybody including me would believe the current political vacuum and intrigues displayed by the Berlin muppets show as well as other sometimes indeed delightful political/legal achievements like the matrimony for everybody were results of their influence via the abuse of my person. This is nonsense. It proves that they watch but do not see, listen but do not hear, dream but do not recall unless I remind them at their nightmares. Matrimony for everybody for example that they and the chancellor (who, by the way, addressed me in front of the whole population in her New Year's television speech on 31 December 2016 as her counter draft (to IS) (instead of as her day and nightmare)) wanted to sell to me as my success was not demanded by me but by 1968 flower power movements and came quite late. I claim my/our/the right to marry two women who love and want to marry each other too ((not yet) so called triangle matrimony; compare Wunderliste in Kafkas Erbe). Conventional (two person) matrimony for everybody is fine but I am not gay not even bi and had no own personal interest in it. As long as triangle matrimony is not even talked about publically I do not benefit at all from matrimony for everybody which, however, might please my fiancé Carmen and our close friend Precious.

I even find it not only NATURE -abusive but -contra productive when in the same time in which I would suffer from hunger unless collecting bottles and cans in freezing below zero temperatures from the streets and Rhine banks of which at least even more than half are clear intentionally without deposit (since beggaring became useless for me because the closed society became quite suddenly more and more non empathic instigated by the contagious inhuman life despising treatment of my abused person by my mother and brother who in ghostly spheres are still claiming the mobilization of human rightful reactions like these (?) on the crimes against humanity) my objective truths and natural ideas of miraculous beauty are kept silent as such and are being transformed on ghostly levels to nothing worthy but undeserved fame for religious war leaders (the whole political class with only very few exceptions (like the current FDP chef) who are desperately trying to save the political-party-fake-democracy having no self-confidence in their persons as single politicians instead of in their party-list-positions what they would need to have if single politicians instead of parties were to be elected)

You have to compare the conflicting interests of Carmen me and our families who are NATURE abusive humiliated on the one hand and the blasphemous aims of pope Franziskus represented by his intimates, my mother and brother, who do not hesitate to sell their own child and brother for some two stupid Dr. h. c. titles. You have to decide if you want to save our lives what you could easily do or serve these catholic creatures. I am sorry that you came into this situation but it was not my idea either to be exposed to this historic world crime. However, if you and me cooperate trustful together you and me are eventually beginning to save **Mother Earth!**
