**Raging Holocaust, Az. 951 Js 1/18**

Dear Mrs. Gaus

Thank you for taking my request for your services serious as you told me when I called you on Monday.

Let me first explain why I am writing to you in English. I am victim of heavy holocaust hard crimes including the ongoing attempt of murdering me which are catholic church crimes committed by using the unnatural law subject German **state** (not it's people) to perform them as they used their (third) *holy Roman empire of German nations* (more commonly known as: third Reich) for the genocide committed against the "Jewish people" during the second world war. I am not really sure but I guess at least three of the six millions Jewish death victims were Germans, weren't they? Hence, the third Reich killed Jews, true, but most of them were Germans. According to law of nature principles peoples defined by their religion do not exist. Hence, neither a Jewish people exists as member of the United Nations nor would the invention of the so called islamic **state** ever have the prospect to be acknowledged as people and UN member. By the way, I do not know why the unholy **state** Vatican has embassies (or are this "nunciatures" only?) nearly everywhere in the world and why (at least during the second world war) ambassadors of numerous countries had their seat in the Vatican and as what the Vatican is considered by the UN today taking into account its lack of an own UN membership capable people in the meaning of law of nations

without at least only one citizen (the unholy father himself is citizen of Argentina as I believe to know) as well as its lack of a language spoken by living human beings not the dead language Latin spoken by celibate clerics only.

To be Jew is a believe, a confession, no nationality. Since most of the death victims were German nationals the German people was the main victim of the genocide during before and after the second world war followed by the Tchech, Polish, French, Russian, Spanish, Italian, many south middle and north American and all other peoples who lost only one single human life in the catholic holocaust according to the definition of genocide (compare Criminal Act of Nations Law (Völkerstrafgesetzbuch)) This genocide has begun during the first world war, Franz Kafka and Felice Bauer being its central victims went on heavily and uncontrolled during the second world war and kept going on after the war without interruption only not visible to everybody any more.

As I informed you in my report of 23 January 2018, page 19, I intended to complain about the violation of my human rights and those of the population(s) of Germany before international authorities. In the meantime I informed Mrs. Theresa May, the British PM, who offers outbound protection on the UK governmental website and Mr. David Lyman, Chairman of the oldest Thai law firm specialized in intellectual property about my case and asked them to follow how I try to defend my by the state of the Federal Republic of Germany (FRG) heavily violated human rights on behalf of the UK and the *kingdom of Thailand*, the home country, and therefore *latest genocide victim*, of my too early deceased wife whose cancer was probably caused by evil catholic means but what was definitively intentionally bad treated and cared for by the German "Social State (Sozialstaat)" the reason why she died earlier as she would have if treated lege artis. Moreover between the first outbreak of her ovarian carcinoma in 2006 and the relapse in 2010 she, too, was terrorized by anonymous abusers of the spiritual sphere for this purpose. I can tell you many friends and guests of my office opening in March 2008 who missed her and her Thai food that she wanted to bring along as much as I did. Instead she became suddenly very confused accused me I had manipulated her mobile phone and had stopped the water supply to our house and stayed angrily away from the office opening. And that was only the beginning of a phase until the end of 2009 in which she behaved extremely weird even mandated a local lawyer to claim horrendous amounts of my/our not yet generated new income after financing most of the office assets and initial current costs. Mrs. Mack (cc recipient) is aware of this episode too. I did not understand it back then first of all because my own consciousness was still limited to its individual base and second because I was not aware of living under the most horrific terror regime imaginable since in addition to my limited consciousness nobody in Germany without exception dared to talk about the reality, at least not clearly and understandable if you are not aware of it. Everybody only used a metaphoric and analogous type of language. A phenomenon of the collective pressure and together with accordingly ambivalent behavior of individuals who not even hesitate to collaborate in the committing of the crimes against their own family members the biggest problem to come over when trying to fight (or only defend themselves insufficiently?) against the holocaust claiming peace purposes all the time on the cost of freedom which would provide for their peace and for peace everywhere on Earth automatically. Instead of the biggest problem you better call it the biggest mistake.

I sent Mrs. May and Mr. Lyman various emails as cc. recipients addressed to different municipal authorities of Cologne as well as to my lawyer, Mr. Krumscheid, dealing with alleged open but paid public broadcasting contributions, the unauthorized third control of my Postbank account, the on resubmission kept supervision (better: control) file 61 XVII 185/15 K despite the official termination of the control, my unlawful detention in a mental hospital in the beginning of January, the abuses of my email accounts by using my "transparent" password.

Then I proposed both of them to let their respective departments act as my barrister(s) in a civil law suit against the FRG claiming compensation of damages which I would nearly completely cede to their countries since I could not find any advocate in Germany for this job (compare the attached email to Mrs. May and Mr. Lyman *proposalofNATURE\_Emailof28January2018.pdf*) . Eventually I informed them about the copied automatic replies pretending coming from the British PM office, the google/gmail website certificate infringements, the attempt to access my own homepage abusing my password too on which I publish my "Kafka's Erbe" narrations all of it reported to you on Monday too.

I hope and trust that this unconventional way of defending major human rights interests instead of a "formally proper" human rights complaint will be acknowledged because as one result of the crimes I effectively do neither have the possibility nor the money to mandate international lawyers. I intend to send all of my correspondence with German authorities in the holocaust context via cc. to Mrs. May and Mr. Lyman and only a few more recipients meanwhile added to the list, namely Mr. David Simpson, London, my friend and personal contact in the UK, Mr. Krumscheid if he is not addressee, Prof. Marcus Arndt of the administrative law firm Weißleder Ewer who represented me when I filed the constitutional complaint about the violation of the human right to LIFE of my wife in 2012 which was rejected on a half page in 2015, Mrs. Alexandra Mack, board member of the advocates chamber of Cologne and from now on Mrs. Petra Eßer of Eßer & Eßer, defending me against a few unjustified criminal law holocaust accusations.

So, this is the reason for writing in English to you and these cc recipients. It has nothing to do with the following two issues:

The lawyer from Bonn who contacted you on my behalf was Mr. Völckers who represented me in the beginning of January when I had to object to my detention. I asked him to let you know that I was prevented from completing the criminal action **951 Js 1/18** of December against my mother. So Mr. Völckers contacted you on my behalf only during my detention but does not represent me in this criminal action any more.

The second point is that I would like to ask you again to agree to communicate with me directly instead of insisting on a legal representative dealing with you on my behalf for a few reasons. First I do not have the money since my income and existence bases were destroyed completely by the first holocaust wave coming over me in 2012 – 2014 (as mentioned the one before that hit my wife I did not realized yet as holocaust crime for limited consciousness reasons back then). Moreover, my little pension that I receive since then and what is already below the existence minimum is systematically and permanently reduced by inten-

tionally and unlawfully initiated public and other costs. I cannot even pay Mr. Krumscheid accordingly for his services in my rental holocaust dispute as well as I do not know when I will be able to pay Mrs. Eßer for her services.

In addition to my financial lack it is a matter of time too. I am very worried about my fiancé, Mrs. Carmen Thomas, who is missed for quite a long while already and who is most probably blackmailed to refrain from contacting me and possibly to do other things she would not want to do. I am very worried about the emotional health of my children as well who have to live with my mother who is blaming evil lies on me spreading them around on every occasion since youth authorities took my children away from me shortly after their mother died. By the way, they are Thai nationals (and Germans) as well. My mother, however, is obviously willing to scarify me to the holocaust what does not only follow from her actions in 1990 reported to you on 17 December 2017 but also from not yet mentioned new pressing suspects which came up after Monday. (I do not refer, here, to further criminal actions of her committed constantly between 2013 and today which, hence, did not come up recently but which I did not mention yet either because I do not want to write whole books every time I complain if only the most clear crimes are not even causing the attention of the respective authorities. I told the health authorities many times seriously that they better care about the worrying mental health conditions of my brother and mother for generally well known reasons instead of that one of their victim but until today they did not move at all in this direction. Another reason why I waived telling you yet about the contributions of my mother in the past five years were the interruption and heavy disturbances when I wrote the second part of my report, as you know. I was happy when I had completed the delivered version. So there are more relevant contributions of my mother, wrong accusations mainly, that I did not report yet because I trusted they would come up during your research anyway as long as it only begins with the right actions.)

On Tuesday, however, I read in *Die vergessene (forgotten) Generation* the Spiegel bestseller of Sabine Bode a journalist again in which she published numerous interviews with time witnesses about the "second world war children generations" which were born after 1945 respectively whose parents still were children during the war. This time I learned from the first chapter beginning with sub chapter *Ein erhellendes Seminar* (an illuminating seminar) that Mrs. Bode visited a seminar which took place in the beginning of the 1990s in Cologne on the occasion of Germany's reunion in which the participants were motivated to look closer at their own family histories before the background of the country's history. Sabine Bode writes on page 26 she had been not the only one there being afraid the distance of their own parents and grandparents to the third Reich always claimed by them had, in fact, not really existed and that the four days of the seminar had confirmed this fear without leaving doubts. Most attendants were born after the war but they too "became aware that the war had become to a determining component in their biography". Each of the participants could tell about at least one case of violence in their families and the amount of near relatives being death victims of the war was higher than the amount of participants. However, Mrs. Bode was quite sure they did not represent a particular group that was extremely hard hit but quite averaged German families and being together on the attendants list was pure coincidence. I am quite sure too it was coincidence and no particular extremely hard hit group (if one does not consider the populations of Germany as such), moreover, that my brother was one of the attendants. He had suffered from the cold war carried into our family when we were young children and when our parents struggled with their own consciousness effective holocaust memories (our father) or their catastrophic Hitler youth (HY) education (our mother). I remember strong circumstantial

evidence for the conclusion that my brother was hit by the typical holocaust effect resulting from the sudden contact with the collective and spiritual consciousness spheres which is over flooding an individual person with information extremely already two or three years before his elementary school age. Probably shortly after or even before my arrival on Earth in May 1969 for him assumingly the worst time to get a little brother. I have photos on which we play together and his face looks like a disguised grimace staring into the camera. On a photo of christmas 1969 you see that his only present was a picture book of a piano and you see how happy (ironic) he was about it. The too early beginning of his music education. On another photo in the arms of our seriously worried looking father he is sick of anything (look at the attached photos). Since my mother did not feed us with her mother milk and my brother was of a smaller stature than his age group with a lighter often pale skin too this sickness might have been a so called dystrophy a diagnose describing various appearances of mental injuries, mainly deep depressions, of world war two veterans who overburdened the German after war psychiatrics (see Sabine Bode page 48f). Children, hence and however, could not suffer from dystrophy as they could not be diagnosed with ADHS the equivalent diagnose for the syndrome under which more extroverted children like me often suffered and what was not yet "known" when I was young. My brother is more introverted and if I am right he received no necessary medical treatment either.

When he reached school entry age with six years already playing piano reading writing and computing he jumped the first class went directly in the second class and still was one of the best pupils every year. However, he was still very young and the terroristic discussions of our parents (in English that we would not realize they were not making love) stressed him and me (soon too) similarly. He stayed whole weeks in his room alone only and complied with all conventional but over ambitious and unholy expectations of my mother.

After we moved from Frechen to Rodenkirchen leaving our father back alone when I was twelve and he fifteen my mother focused not on him any longer but on me and my divine (cynic) life plan going to be scarified about 30 years later even after going to get the development of my collective and spiritual senses suppressed and delayed at its latest natural moment in 1990 as I reported you on 17 December 2017. When we were living in Rodenkirchen for about three years I got into contact with cannabis and liked it. Many friends and others in my age smoked it sometimes and I refused to follow her order to give it up and more than ever to give up my friends only because they smoked weed sometimes. It was not dangerous. Alcohol for instance was more dangerous but allowed and my friends were no bad people coming from no bad families. Otherwise I would have had no friends at all since the other pupils in my school at least were not the types I would have chosen as friends. Today I understand that the reasons my mother claimed for my cannabis prohibition, i. e. her fear I would become addicted to this evil and dangerous drug falling behind and the other typical clichés, were not true but pretended. The truth is that she was afraid my consciousness would develop too early triggered by the dope. That is, finally, what the psychiatrics diagnosed but it was not the reason for *my short experience of leaving my body* when police men took me over after four or five sleepless nights and brought me in the mental hospital. The true cause of my developing and then suppressed consciousness rather than the diagnosed psychose was the heavy stress that resulted from my mother's hardliner education at-

tempts that I had to repel for the next five years nearly every day. Without this stress the dope alone would not have led to the "early" spiritual consciousness experience jumping the collective one because I assume unholy gymnastics as baby bended my back enough to prevent it probably forever under stress free circumstances and without the catholic earworm in 2012.

So both of us were abused for different roles what might have led to emotion displacement mechanisms that my brother obviously developed later and that hindered him so far to have enough courage to stop the unholy play on the collective spiritual world stage which destroys the life's of my fiancé of her daughter of my children and my own one and what prevents much quicker and more effective public attention effects than my single person can provide for.

This might change now.

As I mentioned above I am sure my brother was one of the participants of the illuminating seminar in the beginning 90s. I am quite sure too that it took place when I was in the mental hospital and none of my friends were allowed to visit me. I bet all four named witnesses in my report of 17 December 2017 at least three of them took part in the seminar whose coincidental participation as well as the one of the other participants resulted alone from the fact that they were my friends and my relatives and their parents. My girlfriend back then, the witness Mrs. Beate Böttcher, today Roellenbleck, who was as the only one allowed to visit me and who did this every day during the first four weeks developed soon symptoms of a depression and went slowly on greater distance. Later I learned that she was lucky to have my best friend back then, today her husband and named witness too, Mr. Benjamin Roellenbleck, who spent her a lot of time and consolation (probably vice versa). We are still good friends after I had to digest it first a little bit. And their relationship proved stable until today what helped too over the years. On the seminar both of them as well as my brother and all of my other social contacts were confronted with my later destiny of going to be sacrificed one day to the evil catholic holocaust raging secretly in Germany since the end of world war two. Sabine Bode (an alias) writes on page 27 that on day three the seminar became a pure sorrow event. Everybody cried endlessly. Too shocking was the information delivered on this day. It were their own memories of their own consciousness effective holocaust experiences when they were younger not necessarily as young as my brother when he made his probably harder and longer experience of about seven years I guess. However, everyone had to go through this phase of maybe one or two years because none of their parents as well as nobody else in the country had the courage to talk openly about the problem and to separate justice from injustice law from crime when their own and not at all guilty children were hit by the holocaust and they thought they had to lie to them or even do more evil things from this moment on. Their own memories combined with the secret of my horrible future everybody was threatened with death penalty if telling me was the reason for crying endlessly. It must have been an unbelievable pressure put on them by my mother referred to as Mrs. Gudrun Baumann (the alias Mrs. Bode chose for her) and most probably by "officials" from Germany's foreign ministry (Auswärtiges Amt; AA)

My mother was born in 1933 and educated by Hitler youth (HY). New to me was what she reported to

Mrs. Sabine Bode. She told about an event when she was a child which allows the conclusion that her vegetative nerve and hormonal balance systems were damaged by violating her neck (page 36; she said her mother did it what I do not believe. Much more likely it happened in the school of HY), however, not necessarily chronic, causing organic and emotional insensitivity with respect to the violations of her own body and soul as well as of other souls and bodies (my conclusions. Following from the next Spiegel bestseller *Emotionale Intelligenz* of Daniel Goleman, science journalist of the New York Times, page 34 e. g. and some own medical understanding: the vegetative nerve system transmits organic pain to a point of the kolon (Dickdarm) and from there directly to the brain. Hormones whose function is to providing for emotions as well as to regulate the emotional balance, in contrary, are poured out by glands along the lymph vessels when they receive respective signals from the brain which result from external natural irritations like light darkness charme attraction provocation. They can be activated by unnatural means (tablets e. g.) as well without including the brain in this process. Probably my wife took too long the wrong anti baby pill which has effect on female gender hormones before her hormonal balance got out of order followed by the diagnosis of ovarian cancer. Both signal ways to and from the brain go through the back mark in the spinal column.)

My mother reported, moreover, to feel obliged to attacking me on and on until the end of her life in order to demonstrate holocaust injustice to the population that takes notice of all events on the collective consciousness what can be concluded from her resistance against a trauma therapy in her age of 84 (page 40). Their unlawful and unnatural commitment to scarifying their family member to the collective education of the population in respect to alleged "emotional intelligence" by showing them suffering and abused transparent fellow landmen to teach them emphasis follows from many sources. Daniel Goleman for example refers to this method not conducted by himself but with himself as suffering study object as "emotional education". This has proved as evil lie in my case at the latest, since I showed all variants of proper emotions in different emotional situations and explained more than conclusively my rights to freedom and love which are stolen from me and Carmen since nearly exactly four years at all after being abused nearly more hurting for media and other purposes. Everybody following my "program" on the collective and spiritual consciousness channels feels what I feel and waits for an eternity already for my for education purposes necessary success. Since I did not convince those who caused my undignified current life circumstances to stop their since long wrong influence and lead Carmen and me back together, their blasphemous educational program (at least since the evening of 22 August 2017 at the Cologne Rhine bank they are as everybody else aware of my NATURE authorization, however, ignoring it as if NATURE would provide nothing for their existence) has proved teaching "emotional stupidity" rather than intelligence. Their stupidity, not mine, of course.

Instead of examining my mother the health authorities listen to her and insulted me for many times already knowing it perfectly better. My mother, excuse me, seems to be really mad but able to strongly influence other living beings abusing the holy spiritual living spheres of our ancestors which is, by the way, one of the most blasphemous holocaust methods invented by the catholic church and used as mass destruction initiating means in the first and second world war as well as a terror means against the children generations of the war participants until now and reaches from noise and voices of people who not have died yet (those who have died behave much more respectful and are always welcome near me since we naturally share our common living room) up to real spiritual penetrations of other souls. The enrichment of the soul by other souls can be very pleasant if it not happens without or against the (even expressly declared) will of the "receiver". If the receivers will instead is ignored it is a catastrophic crime which causes sud-

den changes of substantial characteristics in the behavior of the penetrated living beings who then cannot be made responsible for their actions at least if it happened suddenly and for the first or only second time. (Not only humans are concerned. My dog is permanently occupied and influenced as well as the tiger of Siegfried and Roy was penetrated only the single one time when he bated because the catholic clerics could not tolerate this unbelievable piece of LOVE between two living beings on the open public). Only if you know it and how it happens what begins after the second successful and numerous repelled penetration attempts you will be able to save yourself from being penetrated by using your will. This crime method, hence, is extremely dangerous causing wrong accusations playing off males and females against each other as well as other near relatives or friends. This is the true and everlasting disturbance of peace committed by the catholic clericals declaring themselves as peace angels. This must be stopped if Earth and its inhabitants shall be saved. Simple. Nothing more and nothing less.

After all, I am not willing to refer to this unbelievably scandalous way of running our country only between my lines behaving as ambivalent as everybody else what even led to another dangerous increase but decrease of the ongoing German disaster after the NATO double convention which provoked a huge peace movement against the new atomic weapons but not against the by it co-meant (konnotiert) plan of scarifying the next two loving human beings as patriot defense rackets, namely me and Carmen, against new waves of consciousness abuses what was decided probably not yet choosing the concrete "sleeping" victims but on an abstract base together with the known decisions of the NATO double convention. The huge peace movement made the mistake to protest only against the well known decisions instead of against both decisions the secret one by far the more dangerous one why it did not only fail to prevent the new weapons but the new holocaust waves even more sadly too of course and what brought mother Earth on the edge of the next but then certainly last world war during the Kosovo conflict and the world economic crisis in 1998.

Everybody knows that I say the truth here. And most people around the globe are willing to acknowledge my right to talking freely and frankly about it without disagreeing or declaring me mentally ill any longer seeing my personal concern and the danger of a substantial and uncontrollable world wide spread of the holocaust carcinoma.

My purpose is not accusing anybody of being more responsible than anybody else for this nature destroying phenomenon except for the catholic clerics of course. It is only to receive a slight compensation for the life's of my friends and family members that were treated like rubbish for nothing instead of simply addressing the issue. It seems to be an incredible collective psycho illogic barrier to get the right words over the lips even for serious politicians like Helmut Schmidt who certainly would have wanted to stop the madness but who instead pleaded for new atomic weapons if Russia would not take back its resolution to increase their arsenal as well both of which the western and eastern arsenals probably were already much too huge for self defense purposes. So I would not even apply for penalties for the current government any longer if they not tried to stay in charge as renitent as they do and if only responsibility could be noticed by the fact that your detective research will not be obstructed, i. e., by destroying further historic archives like the one in Cologne in 2009 for example even trying



to make stuff of the building firms responsible for it who are certainly not and much better granting you access to the files which concern me personally as well as the German and the worlds public interests the reason for which it is normally denied.

Even my mother might be not guilty for organic reasons if she only did not refuse to let her help and if she confessed her contributions of course. My brother was heavily abused too but he too needs to get rid of his assumed displacement mechanisms since he for sure can help Carmen and me the only persons who are not guilty at all but who are blasphemously abused. However, I assume my brother will not refuse his cooperation any longer.

Therefore, I would propose that you, Mrs. Gaus arrest my mother for the pressing sake of my children. That you talk to the witnesses named in my report of 17 December 2017 as soon as possible as well as that you try to find my fiancé Carmen via the youth authorities in Ehrenfeld and/or the childrens home in Königswinter where her daughter was held for many years in case your interviews should not bring up according results. In this case, however, my brother would need to be arrested too for obvious reasons. He effectively cannot explain otherwise his criminal contributions and respective intentions to the senseless theft of at least six years of my life after its first 42 years were already two thirds handicapped instead of accusing the holocaust injustice clearly without ambivalence as it can be expected (not only) by him as law educated academic. My mother, however, will probably even refuse to confess if she has to stay in prison for the rest of her life. I do not expect help of her.

I would find it unacceptable if you insisted on a legal representative to keep me informed since this would cost much too much of my free life time which not even has begun yet. I am 48 years old. Moreover I am acting as advocate not only for myself but for all living beings worldwide without receiving one single Euro in fees for it yet as well as collective psycho therapist unpaid too. The fact that I gave back my lawyers license following the holocaust destruction of my office does not reduce my legal understanding. It reduces my legal options and personal freedom only.

Since I consider 48 years forced service long enough I do not intend to wait another lifetime for results of your work. I would never put too much time pressure on you but I would like to be informed from time to time because I consider you as my legal representative against the structural state crimes. No criminal lawyer could be found to file the action on my behalf since they declared defending not accusing were their business.

Please understand my reasons why I would like to have direct contact to you in this matter also because only one mediating person can cause, unintentionally, a loss of information or clearness of it preventing in the same time the simple questions I would ask and your simple answers to them clarifying things immediately. I tell you openly that I expect resistance to your research efforts from whoever which will not be your faults. Should it come to such a situation I will not longer waste my life leave the country and apply for asylum elsewhere. I hate every single day of my current life at least since I saw Carmen for the last time. You are my last hope to change our lives. If you cannot help us for reasons nobody can come over I only want to know it as early as possible to terminate my unnatural undigni-

fied and then at the latest more than senseless treatment by the country that I served twenty four months already the time which others have received as compensation for their unwilling and surprising catholic war contributions.

I sent this pdf.attachment by email to the general prosecutor's office email address secured by standard keys which proved safe enough for all official purposes since we are natural persons and can reassure us if any doubts give reason for it before I sent it by mail as well what is another unnecessary and freedom limiting cost factor in my extreme financial situation. I hope you understand this too and we can waive the conventional mail services next time which, by the way, proved collaborating too with the blinding population entertainment called holocaust regularly not finding my address only when Mr. Krumscheid is the sender. Thank you very much for your understanding!

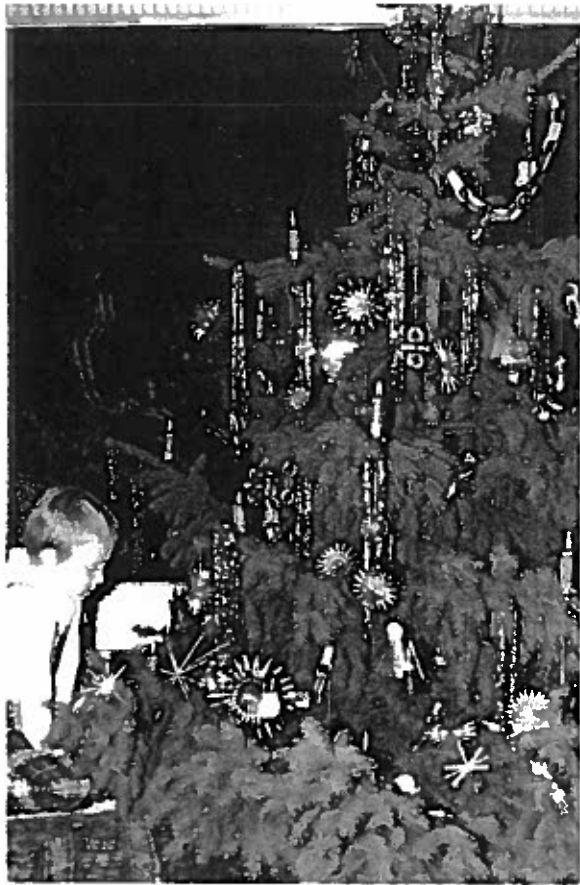

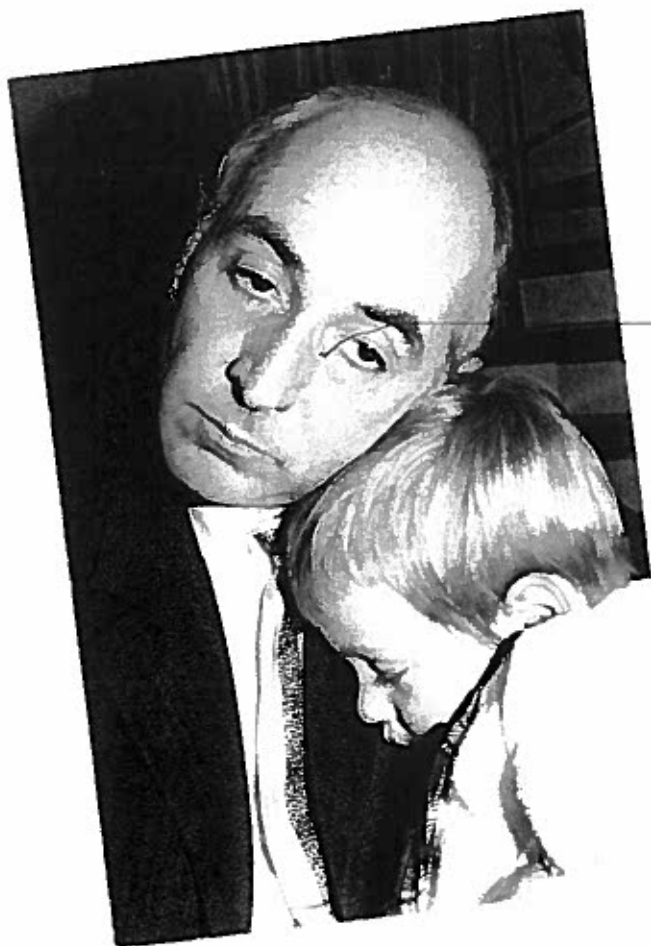
