**Alarming state of mind of my brother, Prof. Claus Kreß, probably dangerous to public safety
My notification on 22 December 2017 and my letter dated 14 January 2018**

Dear Mrs. Spohr, ladies and gentlemen

By letter of 14 January 2018 I asked you, to let me know the outcome of your research regarding the alarming health condition of my brother. Since I was not able to pay my telephone bill because of the unlawful deprivation of my personal freedom from 3 January to 11 January 2018 – I had to pay more than 200 Euro instead for the animal's home – I cannot call you but only be called by you.

The lady who runs the dog paradise in my next neighborhood, by the way, was at her place when you people from PHO (public health office) did not have enough patience to wait for her opening the door, as she told me later, but instead waited in front of my apartment with several uniformed persons and the emergency car well visible for the public around for about half an hour until we eventually left for the hospital. The question is incidental how deep my dignity shall be violated further until also in you the natural persons feel compromised by such obviously unlawful authoritative the population shocking orders and refuse to follow them? Did really nobody learn anything from the history of the country especially from 1933 to 1945 but later on too? Or do I again risk the interests of the Federal Republic of Germany with such self- and common-defensive notifications as I would have risked the interests of the third Reich in 1933 with them? (My brother and my mother, however, can write whatever they want to without triggering any danger for the interests of the Federal Republic of Germany!!!???)

Meanwhile my self-defense situation has clearly appeared obvious not only in the realization of the next freedom-crime in the beginning of January but also in the fact that the „legal public supervision“-file, no. 61 XVII 185/15 K, is being kept open and waiting for resubmission to the officer of (catholic) justice on 9 March 2018 disregarding its official judicial termination on 18 July 2017, whether or not I intend to act on its grounds.

The file overview paper lists some, probably by far not all, involved persons, under them by mother

and my brother with the abbreviation (SB) behind their names. This looks like another gross governmental Holocaust injustice, of which the country suffered more than long enough as I would like to remark. Instead of compensating only the smallest parts of my damages in order to remedy my undignified life circumstances, my mother and brother watch unmoved how I have to sit on the street in winter begging for a few coins having a cold and waiting for February and my next old - 48 - age payment.

Then they follow each of my lines – per cc to the british PM for instance – via spiritual channels not even hesitating to comment on them most the time agreeing.

This *venire contra factum proprium* on the different spheres of consciousness shows on the collective consciousness of society nearly generally beyond dispute their multiply split mind as their allegations of my health condition as potentially aggressive and my detention in the mental hospital applied by referring to them in the beginning of January proofs their danger to the community.

I therefore ask you again seriously to react on my highly personalized report on clear grounds as generally known instead as on anonymous allegations as usually and check their mental health balance not forgetting to keep me informed by call or mail. However, do not visit me never ever in my place again what would be unacceptable please.
