Dear Mrs. May, dear Mr. Lyman

My German lawyers advised me that a civil law suit claiming my compensation of damages plus loss of profits, the latter alone of cautiously estimated 357.5 billion Euros would most probably not be successful disregarding its clear legal grounds.

This is two percent of the German BIP (Gross inland income) only not even the BSP (gross social income) of the past five and a half years the amount of which it would fall according to a German economics professor of the university of Cologne without the stabilization by the Holocaust Crimes. He did not say it with these words but it could be concluded from what he said and the context in which he said it in a television documentation of wdr3 (West German public-service broadcasting) about the Cologne University of Urban VI (the pope who gently granted this regional high school to the people of Cologne in 1388) on the occasion of its 600 anniversary. This would certainly need to and could certainly be verified by checking the respective "money files" of PAAA the archives of the German Foreign Office "Auswärtiges Amt (AA)" which is organizes the **modern slavery** (according to the results of an independent international historic commission appointed by Mr. *Joschka Fischer* in 2006 against renitent opposition of the obstinate AA stuff published in 2010 in the book "Das Amt – Deutsche Diplomaten im dritten Reich und in der Bundesrepublik Deutschland ((Das Amt))").

For the lack of success prospects I did not found someone who would (dare to) file the law suit on my behalf and I filed the criminal action instead as well as my current (kind of innovative live/monitoring) human rights complaint before international authorities, i. e. you, Mrs. May, on behalf of the UK mainly and, backing and beside of you, Mr. David Lyman, Chairman of Tilleke & Gibbins (T&G), the oldest independent Thai law firm representing the kingdom of Thailand. I defend the opinion that formal preconditions of a "proper" human rights complaint cannot be decisive. More than ever in the case of the most vicious, eternal, organized hard crime against NATURE INDIVIDUALITY COLLECTIVITY and SPIRITUALITY in general committed on the back of individuals. In my case my deceased wife, Pat, first, my fiancé I met after Pats death, Carmen, me and - as I have to guess since my senses still were limited to my individual consciousness - our close friend, Precious, four single natural persons and their children, five of them altogether, at least for fifteen years nonstop! The same kind of hard crime which is being committed (I do not know how long but) at least since Franz Kafka and his fiancé Felice Bauer were its central victims in Prague who were separated mysteriously from each other in the end of 1917 exactly like my fiancé Carmen and I are being kept separated from each other now for nearly four years already. Their separation followed Kafka's falling ill of Tuberculosis, two waves of Spanish flu triggering 20 million deaths in Asia Africa the United States and some in Europe, Kafka's own death in June 1924, a cloudy Friday in 1929, a negligible change of the political system of Weimar in 1933 and the little conflict between 1939 and 1945 which was not worth it to exchange most of the diplomatic stuff of AA afterwards who were not aware of the Jewish genocide. However, heavily involved had they been! (compare the generally praised Franz Kafka biography of *Rainer Stach* "Kafka" part II "Die Jahre

der Erkenntnis" and "Das Amt" By the way, one of the historians, **Prof. Ashby Turner**, died of a sudden disease during the research work, a second one, **Prof. Klaus Hildebrandt**, became very sick and needed to be replaced too).

So in order to help me protecting my *human rights* "only" probably nasty military threats or even actions might be necessary what would, in the end of the day, not be very innovative any more. The population in Germany have been very terrified and are not really responsible since they suffer of a quite severe kind of psychopathology. This follows also from the psychiatric statement of Mrs. Dr. Leclerc-Springer who tested my mental health condition for the purposes of my "old" age payments application given to the advocate pension insurance and which is not only by far the best and most objective but the only serious and objective psychiatric statement in my case at all. It reports the result of a so called "F(p)Test" on page 9 that she conducted and what was developed for the use in populations with a significant high rate of psychopathology. And according to my observations - from the view point in the centre of the populations consciousness where the criminal catholic church kindly put me in 2012 when I was living on their ground in a house with large private garden between it and the church of Rodenkirchen on the same ground and flanked by its sacristy where really strange things happened among them a blood plug growing out of my ear about of the size of the head of a quick match triggering shortly afterwards my new open minded attitude - it is perfectly true that psychopathology is a serious problem in Germany.

But now, very slowly, after more than five very hard years for me defending my heavily attacked human rights on the public stage of collective consciousness speaking a clear and not misunderstandable language and analyzing or at least trying to analyze the seemingly mysterious phenomena for most of which I found plausible explanations as well as pointing out the injustice and its motives of the attempt to break my by love carried free and healthy will and most important repelling these attacks successfully to the possible extent (which sadly excludes my wish of being together with Carmen not only spiritually since I had no influenza on her disappearance) people start to relax a little bit since the barriers between the different spheres of consciousness become transparent what leads to a shift of publicity. People see every day more and more that saying the truth about all facts of the crime helps to prevent it and letting the high congregation tilt like a flipper machine what will terminate the crime one day. Acting unfair is not possible any more without the, meanwhile international, public as witness. Saying the truth about it means confronting the acting criminals with what they are doing blankly in the moment they act as well as writing it down and even publishing it on the internet. I did not get tired of complaining about and explaining the typical crime methods of suppressing the individual "transparent" victim by clearly violating his rights again and again, limiting his personal freedom on grounds of wrong allegations, declaring him mentally ill for example after confronting him with his new "transparency" after his thoughts and emotions have been made accessible to everybody around. Introducing him to a new girl friend and forcing her to behave like a trained borderline Julia agent the kind of which were used by the Ministry for State security of the former German Democratic Republic to make their Romeo targets weird what hurts (both) extremely emotionally before eventually forcing her to leave him without a single word of goodbye what again is hurting (both) unbelievably. Limiting his financial latitude by destroying his income base and then preventing him systematically from new

income sources aiming to put him under the existence minimum as Franz Kafka was (see chapter "Pensionär und Hungerkünstler" ("pension receiver and hunger artist") in his biography!). Keeping such kind of pressure upon him for many years. All of which intending to break his joy of life completely, to let him give up his girl friend after she became his fiancé, why it did not work, to let him give up his other rights, to let him eventually wave his claims of compensation and accept his social fall into groundless abysses including the loss of nearly all of his social contacts as his divine fortune, hence isolating him systematically from but integrating him in the same time in his environment. Because I am still waiting for some answers to my questions I could not give up asking them what let the tables turn after about five years. They shot their wad instead of answers. So I am still waiting for those that I did not yet find out myself in order to get rid of the boredom of my isolation. The population around knows me, likes me and helps me. AND they are relaxing slowly not being so afraid any more of talking respectively listening about the ways the machinery functions but developing the common wish to free the country of it.

I consider this process as pleasing and promising necessary to be kept on going and not to be risked. Of course these are only the beginnings of the healing of the society. There are many things still missing, for example an improvement regarding the biggest problem in my eyes the ambivalence of nearly everybody. You never know if you are dealing with a good or bad guy since everybody, especially the closer involved people behave different from how I knew them for the first 42 years of my life but not everybody of them can belong to the evil side suddenly. This is impossible. My feeling for human intentions is not the worst and I would not have kept contact to somebody doing wrong things knowing they are wrong without any reasons. And now since I have been put in the centre of the crime by others they do have reasons since nearly all of them have their own families who they do not want to bring into danger what is clear to see and what they probably could easily have done by helping me too much in the opening four to five years phase. By the way that is why the catholic clerics have implemented their unnatural celibacy. They are the only species on earth as far as I know who are not exposed to this family attack surface which is attacked on the vertical and horizontal levels as one typical appearance of their major skills of love attacks.

In the context of the slowly relaxing population very pleasing and encouraging too is the way local police are dealing with the events and treating me very respectful most of the time. Different from other authorities yet which, however, might seem to change too, only much slower. Hence, the population starts slowly but steadily and increasingly to recover and to behave more natural again. I find this very important because it looked different and nearly impossible for a very long time.

Not only but also therefore I got the idea that maybe you, Mrs. May, i. e. your respective department, as representative of the UK, who I asked to follow the German procedure in order to protect my safety at least a little bit, optionally jointly together with Mr. Lyman and T&G as representative of the kingdom of Thailand the home country of my deceased wife, might be more interested in acting as my barristers suing the Federal Republic of Germany (FRG) for my valid legal civil claims. I think this might offer a much more civilized way to reestablish law and human rights than any military threat or action. Such a

law suit would certainly not necessarily need to be filed in Germany since law here is not evaluated as it should be, especially if the - officially not happening - Holocaust Crimes are the grounds of the claim.

Regarding the money I would not be interested in the whole amount claimable but only in about ten million Euros all together for my fiancé, Carmen, Precious and me plus another million for necessary HIV medication as result of the crimes we had been exposed to if possible payable in advance since we suffered too much and need desperately to recover after coming together again and before following the procedures. Carmen and Precious would have to agree to this proposal of course since I do not yet have contact to Carmen and for the moment (until I can pay my telephone bill) not even to Precious.

The rest of the outcome all three of us would gladly offer to the UK/Thailand for helping us and the whole country presumed that you agree to my **not negotiable** expectation that a Security Council resolution - considering a possible 4:1 as sufficient in the obvious interest of the population of the United States as well (However, I can imagine Mr. Trump shares this point of view) - will be forged in order to open insolvency proceedings over the world wide estate of the roman-catholic church which is led only by a bunch of a little more than 200 cardinals and which is heavily indebted in every country of the world taking obvious claims for compensation of damages into account, as well as in order to showing the world its archives and bio laboratories in its catacombs under the Vatican, the ugly part of the beautiful city of Rome!

The second and already last condition would be to punish my mother and brother appropriately who still let me sit in the street, even yesterday and maybe today after I drafted this letter, missing my abused fiancé for an eternity and begging for living instead of paying me only the smallest amount of money, not even 500 Euro per month, both of them living around the corner and disregarding too their heavy participation in the catholic crimes of which we are the victims.

I think in the context of the trial it will be necessary and justified to take over the control over the FRG for two decisive reasons. First of all it will not be possible to terminate the heavy crime to which the country is used extremely without your help although, as above mentioned first promising developments in the behavior of the population can be observed. In order to keep these developments going in the right direction the close international supervision led by the UK/kingdom of Thailand tandem preferably would be very helpful. Second the FRG is, as well as the catholic church, not only resulting from my claims over indebted enough to justify such measures. I. e., they are probably much more justified than the respective pressure put on Greece for example by the German secretary of finance (for the speculative losses of some major German banks there, Commerzbank for instance). Germany's annual tax income plus social contribution income amounts up to about 50 percent of its BIP. Its annual debts in contrary amount up to 68 percent. Nobody knows how the governmental "Muppets Show" (excuse me please) ever wants to repay these annually increasing debts. The vast majority of my fellow German citizens would therefore as happily as my friends and I would welcome you help to implement a new simple and fair constitution and running the country under your supervision for the first decades.

I hope this might be a considerable proposal.
