Good morning, soldiers! Let us begin with a short review of our preliminary results which we reached so far.

All active german military operations are coordinated under the supervision of christolic state secretaries. These are always international co- operations so far under foreign head command usually, however, which is in occidental coalitions most probably likewise coordinated under the supervision of christolic state secretaries.

After the bomb on Hiroshima instead of Tokyo the sound human mind would have ordered the victors to impose death penalties on the guilty war perpetrators, the complete bunch of Japanese

mps including the government members plus emperor who must have declared their capitulation before the bomb dropped what the Japanese civil population certainly would have done, and to execute all of them without any conscience concerns unless hara-kiri prevented. Was one single hara-kiri registered?

However they missed Tokyo and hit Hiroshima although Tokyo is not such a small target what shows that it was neither intended to hit the cathedral in Cologne nor the suchis in Tokyo. Catholic calculation of collateral still standings.” ...

... could for example be a possible position of admirals and air force generals.

A reasonable resolution, i. e., after conscience approval, from their point might then be:

“We move our Turkey troops to Taiwan if President Xi and Taiwan agree, I assume President Erdoğan does, only to watch Japan and the Philippines closely and come home with all other expats. (Just in case. 70 years only ...)”

However, whatever admirals and generals (with command over abroad troops) decide, stay or come back and receive a true hero's welcome, I mean this without any evaluation – it is their personal conscience decision –, cannot change our natural conscience order in our dimensions of the natural order compliance concept (noc-concept (purple rule and purple concept), need no (n.)oc-decree (in green), do we!?!)) which is for the home troops to intervene without unreasonable hesitation, i.e. without ignoring very reasonable help calls from the middle of the people any longer only because the enemy/ies pretend/s unawareness of them ...

... with which we are back to the inner topic of today, own governments as potential enemies.

We came to the insight that the aggressor in a war against a civil population can be any government, with regard to seventeen German governments any, i. rather e., all of them whereby we used the terms government and mps likewise for government or mps. Members of governments are mps and recruited out of this executive pool, look at Japan and how many minister presidents they had during the second world war. It would just be stupid to distinguish between mp with or without government experience.

Mps on their part are party members since their entrance in the Catholic studying youth or the Protestant path finders, the opposition (during 1933 – 1945 jointly Hitler youth) from where they directly join Junge Union and Jusos. Others start their careers at the latest

in the Jungdemokraten or junge Grüne, the recruitment departments of FDP and popular green party. All of them, now recruited into **the political class**, were from childhood on served sour apples and are conditioned to compromise and into account taking. Their recruitment into their class was trading their natural love (to their people) against money (-career). This is the extended (backwards down to baptism) and systematic curriculum vitae catholicum given for the political class and indeed of most mps (mandated, upper political class).

The party bases of the political class are the greater executive pools who can in states of exception also overrule general election outcomes and vote as devote party soldiers to agree to ignore pre-election promises and enter into the next big coalition as junior partner rather than into opposition or re-election after six months of embarrassing political bargaining!

However, party soldiers are going to meet army soldiers soon.

If you understand german! This context would invite me to a short excursus on reading instructions which might make it easier for you to comply with your first purple order. Six weeks are over soon! However, in favour of keeping the green light line here I prefer an annex to our today papers with some Kafka’s Heritage reading instructions. They give some background in which time and facts context some texts came into existence, how you get familiar with ©bridge, peters synoptic ages bridging chronic, and help avoid a potential misunderstanding of peters archive. You have access unlike some other archives and it is containing the very beginning years of our age. However it does not begin 2019 years ago unlike in similar archives. It were two, so far, hence still quite recent and decent time historic information. However, most of it in german, while the current second volume is mostly in English. Read the annex soon and follow the instructions. Two of six weeks have passed already ...)

This point of view justifies the extension to regard the parliaments as governments. They have to represent the peoples will and their fraction heads only represent them(selves). Not the fraction heads have to expect their vote discipline. They owe it the people. They owe the people that they disciplined stick to their own conscience and nothing else. The fraction heads might then count and deliver the result of their fraction as for me (but then we did not need an honourable pp (the current as unmovable as if in wheel chair, ask the Greeks!) any longer, hence not as for them anyway).

So, is it reasonable to consider the upper political class (mandated) as the actually attacking (and the common party bases as potential) enemy?

Aren't they coming from the population themselves? Isn't sour apple general staple food? Isn't it easier to imagine that one to ten bad guys are real criminals like Milosevic Karadjic Hitler Goebbles and co. than really the whole bunch of stupid mps. Yes of course, stupid are they, but can they really be considered as enemy?

They can. Stupidity is extremely dangerous if its fundament is awe. Awe of christolic beliefs how stupid they ever may be.

But do they really want to harm their own population?

Maybe they do not want to but they do. However, because they believe in forgiveness the population is expected to forgive them every damage they cause and even the same mistakes again and again?

This is not reasonable. However, we are outside the punishable prosecutor and judge crimes looking for the perpetrator of the frame crime and realize that mps obviously benefit from their legal immunity when exactly this unreasonable forgiveness is generally granted.

Their legal immunity against prosecution, however, is not touched by being identified as enemy for what and who we are competent. This much to their in some cases certainly existing but irrelevant lack of intention. They are enemies. Their lack of intention on the other hand indicates that there might be more enemies to detect who indeed do intent (qualified enemy feature) and benefit (high qualified enemy feature) from the damage that they cause.

And their assumed lack of intention is for another reason irrelevant. They are legally responsible. They are the elected representatives of the people. To claim it were not them but their state secretaries who in fact determined the policies (or their fraction head only) is no valid exculpation for them.

And they would never admit this anyway and always claim it was their own policy. Maybe Norbert Blüm is a believer and did not know that the pensions were not safe when he claimed so in the 80ies and even ending 90ies still (you can see the sentence live spoken here: https://www.youtube.com/watch?v=ADz_beum-Qk, the whole parliament debate here: https://www.bundestag.de/dokumente/textarchiv/2012/40879998_kw41_rente_kalenderblatt-209618).

Adenauer and Erhard, however, knew when they implemented the inter generation cost allocation in 1957 already exactly but wouldn't certainly admit either.

Who else needs to be identified as enemy? Who else can be considered less or rather more than them as government too? More than an mp an mg and what about their agencies, ministries, in other jurisdictions called secretaries and their permanent staff here the secretaries?

The state secretaries who guard the(ir) standards (curriculi collectivi).

What is about the state secretaries who are in Germany election immune permanent state agency staff under or above (?) the ministers?

I like how peter put it in Kafka's Heritage. Maybe you read "crime time table part two" already. On page 3 it reads:

Their "bosses" the "elected" ministers do not have any clue of their resorts like the mother of seven never passed a basic army education and are therefore able to head any ministry since they do not know anything anyway.

Whether under or above, this is effectively why never reasonable reform attempts are made but blocked by the state secretaries standards set. They block intentionally what makes them even potential qualified enemies.

some Kafka's Heritage reading instructions

... ©bridge offers entries in the time and fact context of this embarrassing polit bargain after the last general election too. Please find them yourselves by applying peters

synopsis on the left side. You know the catholic date of the last general election. Easy to find on the left side of @bridge. (By the way, the other way around works too of course. If you read an interesting text and want to know when for example the 27.11.2 was according to still applicable conventional christian time calculation you quickly open @bridge year 2, go to moon 11 and there you see the catholic date of day 27 in ()).

Interesting to read this time context in @bridge year 1 (after you opened year 1 (and read the big red entry) go to May and study the synopsis first. Some entries since aug1/dec17 are already in English too) also because of a few more international events (Skripal) and developments (of penfriendships for instance) between peter on our and global and regional heads of enemy catholic church on their side. Arch bishop cardinal Woelki of Cologne founded a catholic charity, called "rogamus" in order to promote even more ghostly callings after peters email on Nicolaus day 2017 to him and Francis declaring their ridiculous apostels creed obsolete and replaced by the simple commitment to (natural) truth.

(Compare the respective entries in @bridge when you read the correspondence, quoted in various of our materials! Do it this time. You do not need to do it always and you do not need to read all chronic entries. Many of them are quite personal, peters to do's for example. However in the time context of this correspondence peter also was writing a criminal action to be filed with the po and was arrested and admitted to mental hospital for ten days (he filed the action after his release, including this attempt of punishment prevention in favour of the accused persons in peters action!) and only three months later again (when he wanted to inform Ms. May about some Skripal background), all of this is noted in @bridge. Getting familiar with the synopsis and getting an *idea of the essence of @bridge* by reading some of the entries in every year is sufficient for compliance with your first purple order with respect to @bridge (*in year 2 peter waived months names in favour of just moon 1 – 12. It was reproduced after London police had arrested him, admitted to a London mental hospital, for a change, and stolen peters last xls.copies on his stick in the first half of the year (summer 2018) and it contains only a few entries made in the end of the year (including this hospital admittance his escape from the hospital in London and the British entry in the European Schengen Information System, which prevented his escape in this year a second time when two months later the passport control at Schipol Airport Amsterdam took too long due to the british SIS entry and peter missed his flight to Bangkok. The ticket was not reimbursed. The current year 3 is probably most interesting. You can follow peter here. He protocolled his clear eviction resp. eventually successful escape out of the german EU hell in this summer and lets his readers, since, quite regularly know what he is doing, if it is not writing, what they see anyway. So not having read every word of @bridge but being familiar with its use fulfils the fact of having read all of Kafka's Heritage with respect to @bridge. The different characters of entries in the first three years show, however, quite well that peter is not only the author of this chronicle. This is his side occupation. His main concerns were being evicted from his fatherland and now being (Holocaust-)war refugee! Never, forget this. He was under extreme high pressure during the years 1 and 2. He felt his freedom coming back to him not before his first month outside the EU in Istanbul. From then on the entries start to become more relaxed and systematic.*)

Francis joined rogamus a few weeks later as first honorary member after peter had friendly complained about the holy father's unawareness of anything pretention as well as about the ongoing natural consciousness abuse by their rcLimited in officio sub, the meanwhile notorious, CIGoH (Colonia Indignidad Gesellschaft ohne Haftung), how peter uses

In this complaint David (little peter) told Goliath (holy father Francis) how he was approached by unknowns who offered honorary membership in their anonymous secret society and how peter friendly declined this generous offer (peter published both, initial email of 61217 and this friendly complaint together in one file as “the beginning of a penfriendship” (now archive) and here <http://familienzuechtigung.com/sites/default/files/pdf%20/thebeginningofapenfriendship.pdf>).

The Skripal poisoning thing then happened after peter had published “real vs. artificial art” another and soon last email to the cologne cardinal in lack of Francis’ email details in which peter warned both of them that their (united church states-) organisation face international action (starting in Berlin) in order to correct the mistakes made during and after the second world war. Whereas peter appealed to the feeling of honour of the successors of the four victory allies, motivated and supported by China, back then not involved in Europe, the pope obviously started to fear the international security council for the first time ever when peter predicted Francis that still due (never imposed) penalties after Germany’s (and Japan’s by the way too) unconditional capitulation in 1945 would soon be executed.

The catholic church has enough influence in Britain via their cousins, some Arch bishops who assume the right to throw British Queens and Kings, and their house of lords whose rather ghostly than “spiritual” members are represents of the British cleric and (s)nobility. They are not only responsible for the Skripal attack. Much more embarrassing is their brexit blockade.

Peter also hoped long for a May commitment to the British people and their brexit for various reasons first of all international legal recourse since he had exhausted all reasonable national recourses without any success already, including administrative/constitutional, criminal and civil law. In Germany you may only complain about the violation of your own basic rights. Other complaints are rejected. Jesus would have been able to complain after his execution but that was not his intention when he rose from the hell of the dead in which he had descended from their crucifix and ascended straight into heaven to be seated at the right hand of God the father Almighty! (compare apostel's creed, lines 8 to 12)

However, peters wife did not rise from the dead again and if she would have she had certainly likewise preferred a seat next to god.

The complaint itself, another 68 pages of probably the best german law firm in administrative law did not bother the court at all. This is our legal reality which nobody bothers. ... but us.
